I hereby waive and relinquish and discharge all claims which I now have or may subsequently have as a result of the operation of the Vehicle, and fully release and discharge the City and its Officers, employees, agents, council members and servants, from any claim that may arise from the operation of the Vehicle.

I have received, read and understand the "Golf Cart Ordinance." I have paid the permit fee for the above golf cart. I also understand that the City of Lake Station Police Department and/or City of Lake Station interpretations of all the rules and regulations are final. I will insure that any assigned proof of compliance will remain attached to the golf cart at all times. I furthermore insure that I will obey all the rules and regulations set forth by the City of Lake Station concerning the operation of the golf cart within the city limits.

Applicants Should Familiarize themselves with the City of Lake Station Municipal code (Ordinance 2018-08) for regulations concerning the use of Golf Carts before operating on City of Lake Station streets, including age and licensing requirements, locations permitted, and other restrictions.

Permits must be renewed each calendar year prior to operation on City of Lake Station streets
